Developer has agreed to complete required stormwater improvements and related earthwork as outlined in the Developer's Agreement, provide escrow funds equal to 110% of the estimated costs as financial security, grant easements to the Township and Authority to allow the work to be completed if necessary, and enter into an Agreement of Sale that reflects these terms.
